DISCUSSED it was discussed that Cllr Taylor-Smith had resigned from her role as Viking Ward Councillor in August. In accordance with the duties of the Council, Electoral Services had been informed at Thanet District Council and notice had been posted on all Town Council notice boards and on the Town Council website. The deadline for parishioners to

request a by-election was the 26th September 2018. If no by-election was to be called then the Town Council could immediately start the process of co-option.

197 PIERREMONT HALL ROOF

DISCUSSED that in accordance with the financial regulations and standing orders a formal tender for the replacement roof at Pierremont Hall had been undertaken, public notices had been placed in the local newspaper and newsletter and an advert had been placed on the contract finder website. The tender process was undertaken between the 31st August and 14t September 2018, no tenders were received.

Subsequently, the Project Manager had approached three roofing firms to obtain quotes. One firm had failed to formally quote, the two remaining firms were:

Alan Ball roofing, Dover: £67,875 inclusive of vat but excludes scaffolding, quoted at £19800 +VAT

John Couzens Roofing, Broadstairs: £71,550 inclusive of vat and scaffolding Quotes were comparative quotes for a replacement roof in slate, with zinc flashings. The roof would be a lead-free roof.

Proposed that the contract to replace the roof at Pierremont Hall be awarded to John Couzens Roofing, Broadstairs- Proposed Cllr Binks, seconded Cllr Buckley, agreed RESOLVED
