## 0348/DF 90 Botany Road

Recommend refusal on the grounds of overdevelopment and suspected backland residential development.

## 0323/VK Little Newlands Piggery

Concerns - Introduction of a septic tank - needs power supply. Running a generator close to residential properties is not acceptable. Lack of cleansing on sewage will pose a severe environmental risk.

Re-positioning of hard-standing and additional access would enable more vehicles on site - recommend reminder to comply with Appeal decision to limit vehicles on site

Recommend refusal if a generator is to be used

### 0354/VK 4 Guy Close

Concerns - The proposal makes the rear very dominant. Although it cannot be seen from the front, it can be seen from the coastal roads.

#### 0164/VK 112 Dumpton Park Drive

Concerns - The proposed alterations are of a poor design.

## 0422/VK 21 Selwyn Drive

Concerns - The proposed alterations will dominate the rear of the house.

## 0405 - 4 Hildersham Close -

Recommend refusal on the basis of Missing Information (arborist report), Affect Local Ecology and Other (the work is unnecessary for the Pear and there should be a condition that the Walnut must only be worked on in Summer/Early Autumn).

#### 0226 - 51 St Peter's Court

Comment: - Information missing from plans - Not enough info given on application. There is no report from the TDC Tree Officer for this TPOd tree, nor a location plan of where the tree is, nor why the work is requested.

#### 0273-81 Kingsgate Ave

Comment - There is no report from the TDC Tree Officer for this TPO'd tree. Comments fro an arborist would be beneficial.
