22 CORRESPONDENCE AND CONSULTATION RESPONSES

DISCUSSED the Town Clerk provided the following verbal updates:

- -TDC had confirmed that it would now release the next £200k instalment of the S106 money, for the refurbishment of Pierremont Hall. An invoice had been sent to TDC for this money.
- -Toilet Survey- An advert would be placed on the Town Council's website on the 4th June looking for people to undertake the toilet survey. The survey would

commence week beginning the 10th June. The Town Clerk thanked the Cllrs that had offered to undertake this piece of work.

- -The new Cllr Ipad and Android tablets had now been ordered.
- -The Butterfly conservation group had contacted all Kent Parish Councils to ask for support for the big Kent moth and Butterfly survey. As the Council was not in a position to offer a function room, the Town Clerk would pledge £100 to help support this project.
- -There will be no toilets available in the main part of Pierremont Hall from the 17th June, due to the removal of the Asbestos toilet cisterns. Therefore, from the 1st July all evening meetings will be held at the Crampton Tower Hall.
- -The Town Clerk will email all Cllrs regarding an update to the schedule of meetings. This will also be updated on the website.
- -Correspondence had been received from the strategic planning manager at TDC regarding the Neighbourhood Plan examiners report and a conflict they had identified with the Reading Street LGS. They had identified at this late hour that the LGS conflicted with a Local Plan site boundary. The Town Clerk was awaiting further correspondence and would update Cllrs in due course.
